In late 2015, Lilly Endowment Inc. made grants to benefit 28 organizations totaling more than \$28 million in its National Initiative to Address Economic Challenges. In late 2016, a second cohort of grantees was added to the Initiative, and a third cohort was added in 2022. These grants were awarded to a variety of organizations across the nation that are using them to help pastoral leaders develop stronger financial literacy skills and provide direct aid to help these leaders reduce or eliminate education debt, participate in pension programs, pay off extraordinary medical bills, and address other financial challenges.

#### MINISTERIAL EXCELLENCE FUND

The priority of the Ministerial Excellence Fund is to award active pastors who are challenged with seminary debt. When pastors are challenged economically, research has shown that it hinders the spiritual growth of the overall congregation and its ministries. The fund will be structured to provide grants, allowing active pastors to apply for a grant with a maximum amount up to \$5,000. There will be an application process that will decide which active pastor is eligible to receive the grant.

The grant will be applied directly to the third party that holds the pastor's seminary debt. All grant recipients will be responsible for appropriate IRS filing. The grant Finance Director will provide financial management and oversight of the Ministerial Excellence Fund.

We make use of the following resources: Villanova's Certificate in Church Management; Lake Institute's Cultivating Generous Congregations; and the National Leadership Roundtable Toolbox. o National Leadership Roundtable Catholic Leadership 360 program uses a 360degree assessment tool to provide feedback on key leadership competencies and behaviors that have been shown to contribute to the success of Catholic pastoral leaders and to identify and map out a plan for ministerial leadership development. o Intercultural Pastoral Institute - cultivates pastoral leaders, giving them training, skills, and attitudes necessary to confront the reality of our society and the needs of Catholic Community. o IPI's Pastoral Leadership Certification -The curriculum is based on the teachings of the Catholic Church within these four areas: human development, spiritual/theological, pastoral, and intellectual. All courses are taught in Spanish by competent instructors in the different areas of formation. o Priest Peer Learning - Programs addresses the workload stress of our Pastors. The Peer Learning program has a group of Pastors and a Facilitator who meet in monthly sessions. The group includes Pastors with many years' experience with pastors with limited experience and leading their first parish. The sessions integrate spiritual self-care and care of the congregation with management. These are facilitated discussion designed to learn from each pastoral leader's practices.

Empowering Pastoral Leaders

#### MINISTERIAL EXCELLENCE FUND

In phase I, the MEF offered financial assistance to parish full and part-time (15 hours per week) lay leaders who were experiencing financial issues. In 2017, \$26,390 was raised and grants (totaling \$49,600) were awarded to 16 individuals.

In Phase II, after COVID, rather than awarding grants to individuals to provide partial relief to a 10-20% salary reduction due to parish revenue reductions, the MEF granted awards to a parish stewardship program to increase parish revenue. The increased revenue enabled staff retention and improved staff wellbeing and decreases their stress levels.

#### OTHER PROJECT COMPONENT

Archdiocesan Presbyteral Convocations - The Archdiocese conducts the Presbyteral Convocations to provide additional leadership and financial training to all Pastors and Parish Life Coordinators and to enable status checkpoints for the implementation of the Archdiocesan Pastoral Plan.

A second focus of our project has been on financial literacy for pastoral leaders including redesign of our retirement plan, connecting leaders to financial planners, and communications about financial literacy to all church members.

Our Economic Recovery & Resiliency Program for Pastors will help pastors build long-term financial sustainability for themselves and parishes they shepherd in extreme financial distress. A main component of the program will be establishing an Economic Recovery Project Management Program to serve pastors in Puerto Rico, where 1,000 disaster-struck Catholic parishes sustained nearly a half billion dollars in damages. Education opportunities include helping pastors with fundraising.

- support priests' retirement through a Charitable Gift Annuity Matching Program for financially insecure senior pastors throughout the country.

#### OTHER PROJECT COMPONENT

We anticipate engaging at least 300 pastors in Puerto Rico in the project management program and help 170 pastors in Puerto Rico and beyond through the MEF.

Since 2016, we have offered Financial Literacy
Academies for a total of four days each year. One day is
devoted to pastors' personal finances, one to
congregational financial best practices, one to preaching
and teaching stewardship, and the fourth day for

Clergy grantees, spouses, and lay leaders are required to
attend pertinent sessions.

#### MINISTERIAL EXCELLENCE FUND

Current MEF provides financial relief grants for pastors to either respond to debt or to shore up retirement resources for those nearing retirement age without adequate resources set aside. Grantees must participate in above listed financial literacy, participate in peer groups with a coach, and meet with a financial advisor before funds are released.

Our phase 3 grant also provides small incentives to all congregational clergy to participate in the Pension Fund, making use of their Benefit Accumulation Accounts for savings, Your Money Line resources from Pete the Planner, and Learn to Live mental health resources.



We provide financial group coaching opportunities, six free sessions with a financial counselor, and workshops on student loan repayment options accompanied with six free sessions with student loan repayment counselors. Those who receive educational debt reduction grants participate in goal setting conversations with connection to needed resources.

## MINISTERIAL EXCELLENCE FUND

The Investing in Leaders Resource Grant provides up to \$5000 to clergy per year over five years (total limit is \$25,000). Eligible clergy must complete financial education and/or student loan repayment counseling along with a goal-setting conversation annually.

## OTHER PROJECT COMPONENT

The Practical Church Leadership graduate certificate program, created through the ECFPL project, is offered by Dakota Wesleyan University for clergy in the Area. 80% of the tuition is covered using grant and raised funds with the pastor and church funding the remaining 20%. The year-long online program addresses critical competency development for clergy in the areas of: financial management, financial development, governance and human resources, vision and strategic planning, communications and outreach. Credits earned contribute to the MBA in Nonprofit Leadership.

ECF created a holistic approach during times of transition in the arc of ministry to address financial and leadership challenges of congregational ministry -- for clergy, these transitions occur during seminary, preparing to move from seminary to parish ministry, and taking on a first cure or new rectorship. Both personal finances and effective financial and managerial leadership were addressed.

ECF offered in-person and online conferences, tools, resources, and curricula partnering at the judicatory (diocesan) and congregational levels using a top-down and bottom-up approach to connect. ECF then moved on to pilot our congregational leadership initiative conference on a learning management system/platform to enable synchronous and asynchronous capability.

## MINISTERIAL EXCELLENCE FUND

ECF's MEF diocesan-based program provided grants to entrepreneurial clergy with the ability to transform congregations but for whom personal financial challenges provided significant impediments – cost of housing, seminary debt, and inadequate congregational compensation.

For seminarians and ELCA rostered ministers, we promote and encourage financial counseling through Lutheran Social Service (LSS) Financial Counseling.

For ELCA congregations, we offer the Congregational Financial Assessment, an online program where congregations can assess their proficiency on a set of 21 healthy financial practices, and access resources intended to help carry out each practice.

## MINISTERIAL EXCELLENCE FUND

For many ELCA rostered ministers, financial stress stands in the way of satisfaction and effectiveness in ministry. Frequently, this stress is due to a lack of emergency savings, a lack of retirement savings, or both. To address these challenges, Resourceful Servants offers two Savings Matching programs, one for emergency savings and one for retirement savings.

## OTHER PROJECT COMPONENT

Resourceful Servants has also supported fundraising efforts of ELCA Fund for Leaders which provides scholarships for seminarians, helping them graduate with less debt and empowering them to go and serve "as the church needs and the Holy Spirit leads." In Phase III, grant funding supports scholarships for ELCA candidates in the Theological Education for Emerging Ministries (TEEM) program. This program allows students to study at home with local pastors/mentors, while doing ministry in their home congregations.

The Financial Wellness Assessment and subsequent annual evaluation forms. This assessment looks at a variety of metrics related to financial wellness. We use a version when participants enter our savings matching programs and then again each year as a follow-up. We have been able to measure participant growth in financial areas over the course of years.

The Congregational Financial Assessment. We created this assessment as a way for congregations to identify how proficient they are on a set of 21 healthy financial practices, and then to deepen their financial knowledge and improve their behaviors. We believe that doing the latter will enable congregations to best use the funding available to them.

## MINISTERIAL EXCELLENCE FUND

Financial assistance grants to help pastors alleviate financial burdens such as medical, credit card and educational debt. For Phases I and II, grants of up to \$5,000 were available, split evenly between MEF monies and matching dollars from churches, middle judicatories, and other networks. These grants included a 20% income tax "gross up," also split equally between matching dollars and the MEF. Recipient pastors were required to meet with an Everence financial consultant or an LSS certified budget and debt counselor prior to receiving the grant. For Phase III, grants are earmarked for pastors who exhibit dire need, are under-represented, and/or are most harshly impacted by the effects of the COVID-19 pandemic. Recipient pastors must be referred to the program by their denominational or middle judicatory leaders and/or an Everence stewardship consultant and are not required to match dollars from their churches, middle judicatories, or other networks.

## OTHER PROJECT COMPONENT

In Phase I, we offered a pension fund grant (utilizing MEF monies) tied to our pastoral financial education events. Those who attended an event were eligible for a \$250 matching grant to start a new (or add to an existing) Mennonite Retirement Trust account. However, we discontinued this component following an evaluation at the close of Phase I, when it was determined this component was not gaining traction and/or valued by the program constituents.





Educate Clergy, Clergy spouses (Presvyteres), Hierarchs, and lay leaders on the unique challenges of the Clergy family through Zoom programs, national and regional meetings by sharing our findings from two research studies. Created two Zoom-based Financial Wellness Video Series of approximately nine (9) programs – one for the Clergy and the other for the Presvyteres.

## MINISTERIAL EXCELLENCE FUND

Clergy enroll in the MEF Program by completing a brief survey, and then must complete the Dave Ramsey Financial Peace University Program, as well as enroll in Pete the Planner. Throughout the process, mentoring with a senior Priest is provided. Lastly, clergy must complete a Post Program Survey. Once the program has been completed, a debt alleviation grant of up to \$10,000 is awarded and paid directly to the debt agency.

- 1) Presvyteres are the principal managers of family finances in many of our Clergy homes.
- 2) There is a component of loneliness for many of our Presvyteres.

We are offering a variety of virtual courses at various times through the year based on the new United Methodist financial literacy curriculum, Saving Grace: A Guide to Financial Well-Being. Our approach emphasizes the theological warrants for stewardship, with a special emphasis on equipping pastors as financial leaders in their congregation/community. The average class size is 10-12 pastors/staff/lay volunteers.

To facilitate financial ministry in the local church and community, a 2-hour Financial Health Basics workshop presented by our financial coaching team is now offered.

## MINISTERIAL EXCELLENCE FUND

Our project's MEF operates as our Clergy Well-Being Grant program in which all appointed clergy in the Missouri Conference are eligible to apply for grants to reduce student loan debt, consumer debt, moving expenses, as well as grants for renewal leave, lost income or savings related to the pandemic, grants for continuing education, grants for educational enrichment programs for children of pastors impacted by the pandemic, and seminary scholarships for students emerging from our under-represented congregations. Clergy Well-Being Grant applications have tripled since Phase III funding has been granted. Grant applications are reviewed by an application review committee monthly.



## MINISTERIAL EXCELLENCE FUND

The matching money for our MEF came through the synod council which designated legacy gifts made by congregations who closed during the grant period to the EMU project. This buy in from the synod leadership has been instrumental in the success of our project.

Student debt relief grants were noncompetitive and were made in the fall of each year.

We had particular success with our matching incentives for pastors to make contributions to their retirement plans in addition to the money put in by their congregations. It was a three-year step-down program where in the first year, you put in 1 % of your Salary and we would put in 2 %. In year two you put in two percent and we put in one, and in year three you are putting in 3 %.

Additional incentives were available for health savings accounts.

During the pandemic, the synod council made an additional commitment to EMU and Lilly Endowment gave us room in Phase II of our grant to make emergency grants to anyone who experienced loss of income or increased expenses as a result of the crisis.

The resources of Lake institute have been very helpful. Particularly the Executive Certificate in Religious Fundraising and the Cultivating Generous Congregations course for congregations.

The 6 weeks on Money course is currently getting good reviews from participants.



We improve financial literacy by connecting ministry leaders to the resources they need. The primary activity in our program is connecting clergy with financial planners from Everence. We have also connected clergy and their families with financial coaches from LSS financial. Additionally, we continue to find ways to work with the Lake Institute on Faith and Giving to cultivate generosity in congregations.

#### MINISTERIAL EXCELLENCE FUND

We have implemented multiple phases of the ministerial excellence fund. "Debt Relief" provides large grants to reduce or eliminate burdensome debt. "Retirement Kickstart" partners with pastors to increase their retirement savings. Financial Education and Practical Exercises: Topics include personal and church financial management, engaging church boards on financial topics, and teaching congregations about biblical stewardship. Spouses are expected to participate in the program. Educational materials and resources will be curated from a variety of professional sources; partners may include Thrivent, NAE, YNAB, ECFA, Clergy Advantage, and other organizations.

Connection Groups: 18 mentor-directed 90-minute zoom meetings over the 24-month program. The mentor will be pastorally-minded with a focus on the emotional roots of financial decision-making habits. Each cohort will be divided into small groups of 5-7 participants/couples. The call, related to the educational topic of the month, is facilitated by the mentor and includes time for each participant and their spouse to share.

Financial Well-Being of Pastors Fund (FWBPF): The FWBPF provides encouragement and incentive to pastors and churches to engage in the systemic change we seek. Lack of retirement funding and personal debt were identified by pastors as significant financial stressors in research conducted by Vineyard USA in 2022. The primary focus of the FWBPF is to assist pastors in establishing retirement funds, developing habits of regular contribution to retirement funds and eliminating debt.

To encourage healthy local financial systems and rhythms, we have elected to match pastor and local church dollars with FWBPF funds. We believe matching

encourages both pastors and churches to actively take responsibility for their respective roles in pastor and church financial health.

Pastor households that successfully complete activities of the Financial Well-Being of Pastors Initiative (FWBPI) will be eligible to receive up to \$5,000 from the Financial Well-Being of Pastors Fund (FWBPF). Up to \$1,250 (including \$250 of tax make up in some cases) in matching funds will be available every six months over the 24-month program.

In the first year of the program, pastors may apply up to \$2,500 (including \$500 of tax make up) of FWBPF funds towards existing personal debt. All payments in the second year of the program will match contributions made to a retirement savings account in the name of the participating pastor.

Pastors will complete an application form and provide documentation sufficient to establish that retirement contributions or debt payments for which they are requesting a match were made.
